Heated Tents shall be considered indoor space therefore assessed at full tap fee rates

System Investment Fees, User Fees and a grease trap or interceptor are required for all food service establishments engaged in activities of preparing, servicing, or otherwise making available for consumption foodstuffs that use one or more of the following preparation activities: Cooking by frying (all methods), baking (all methods) boiling, blanching, roasting, toasting, or poaching, infrared heating,

searing barbecuing, and any other food preparation or serving activity that produces a consumable food product.
